# Casias returns to Tribal Council to serve fourth term

"This is a day of celebration," Southern Ute Chairman Christine Sage declares as the swearing in ceremony begins on Monday, June 18 for Pearl Casias; the newest elected Tribal Council member.

Casias will fill the last seat on the Southern Ute Tribal Council, following the special election held Friday, June 15. She was confirmed as the highest voted candidate in council chambers and won the election with a total of 105 votes.

"I look forward to getting work done!" Councilman Cedric Chavez proclaims after the swearing in ceremony. This will be Casias' fourth term with the Southern Ute Tribal Council, she has previously served 10 years on council and worked for 12 years as the Southern Ute Indian Tribe's Chief Judge. Casias made history as the first woman to serve as Chairman of the Southern Ute Indian Tribe.

In her previous years spent on council, Casias implement Tribe's financial plan and she oversaw the creation of the Southern Ute Growth Fund and the in-house Tribal Attorney Department.

"We must continue to be vigilant, we must find ways to empower our youth, and I am honored and humbled you elected me as your new council member," Councilwoman Casias said after taking her seat with the South-







# Air quality health advisory

Staff report SAN JUAN BASIN PUBLIC HEALTH

Smoke from the Burro and 416 Fires should remain within the Durango and northeastern Montezuma areas. Affected areas include portions of Southwest Colorado, including La Plata, northeastern Montezuma and eastern Dolores Counties. Locations include, but are not limited to, Durango, Rockwood, and Hermosa.

San Juan Basin Public Health (SJBPH) in conjunction with Colorado Department of Public Health and Environment (CDPHE) have placed additional air quality monitors in the area. Data from the monitors show the amount of all the microscopic particles in the air that can cause respiratory problems, especially for individuals with respiratory illnesses or heart disease, the elderly, and children.

**DISCLAIMER**: When viewing data on the map view of PurpleAir. com, please note that the real-time concentration of fine particulates is displayed. While this information is useful, CDPHE and SJBPH advise using the 24-hour average of PM2.5 for health recommendations. The PM2.5 24-hour average is the official health standard set by the U.S. Environmental Protection Agency.

San Juan Basin Public Health advises that you consider limiting outdoor activity or remain indoors if smoke is thick or becomes thick in your neighborhood. This is especially true for those with heart disease, respiratory illnesses, the very young, and the elderly. Consider relocating temporarily if smoke is present indoors and is making you ill. If visibility is less than five miles, smoke has reached levels that are unhealthy.

### Other tips to protect yourself:

- · Close windows and doors and stay inside. However, do not close up your home tightly if it makes it dangerously warm inside.
- Only if they are filtered, run the

air conditioning, your evaporative can be found at many hardware and cooler, or the fan feature on your home heating system (with the heat turned off). Keep the outdoor air intake closed and be sure the filter is clean. Filtered air typically has less smoke than the air outdoors. Running these appliances if they are not filtered can make indoor smoke worse.

- Use HEPA room air filtration units if you have them.
- · Avoid smoking and/or secondhand smoke, vacuuming, candles, and other sources of additional air pollution.
- Do not use paper dust masks; these do not filter out the particles and gases in smoke.

As temperatures cool in the evening inversion conditions worsen and smoke in low lying areas may become thicker, especially if the outdoor air is still. It tends to be worst near dawn.

- Close bedroom windows at night.
- To prepare for nighttime smoke, consider airing out your home during the early or middle of the afternoon when smoke tends to be more diluted. Use your best judgment. If smoke is thick during the day, follow the tips above.

### Will a face mask protect me from wildfire smoke?

San Juan Basin Public Health recommends that the public seek advice from their Primary Care Physician (PCP) regarding if they should wear a mask in our smoky conditions. The PCP will best know the health of their patients and make appropriate recommendations based on that knowledge. Respirator masks labeled N95 or N100 provide some protection – they filter out fine particles but not hazardous gases (such as carbon monoxide, formaldehyde, and acrolein). This type of mask

home repair stores and pharmacies.

- · Choose an N95 or N100 mask that has two straps that go around your head. Don't choose a onestrap paper dusk mask or a surgical mask that hooks around your ears - these don't protect against the fine particles in smoke.
- Choose a size that fits over your nose and under your chin. It should seal tightly to your face. These masks don't come in sizes that fit young children.
- · If your child is experiencing respiratory symptoms contact your pediatrician or go to the nearest emergency room.
- · Don't use bandanas or towels (wet or dry) or tissue held over the mouth and nose. These may relieve dryness, but they won't protect your lungs from wildfire smoke.

Anyone with lung or heart disease who is chronically ill should check with their health care provider before using any mask. Using respirator masks can make it harder to breathe, which may make existing medical conditions worse. The extra effort it takes to breathe through a respirator mask can make it uncomfortable to use them for very long. These masks should be used mostly by people who have any health conditions listed above, are elderly, or who need to engage in strenuous exertion outdoors. Please contact your primary health care provider if symptoms persist or become more severe.



# CDOT prepares for '100 Deadliest Days'

Increased safety enforcement and outreach

COLORADO DEPT. OF TRANSPORTATION

More fatal crashes happen on Colorado roads during the three months between Memorial Day and Labor Day than any other time of year. To keep drivers and passengers safe this summer, the Colorado Department of Transportation (CDOT), Colorado State Patrol (CSP), local law enforcement agencies and other safety partners are collaborating to implement several safety enforcement and outreach efforts across the state.

More cars on the road, an increase in motorcyclists and teen drivers, and a historic increase in impaired driving are all factors contributing to a spike in motor vehicle fatalities during the 100 days between Memorial Day and Labor Day. Since 2013, 908 people have died in crashes on Colorado roads between June and August, accounting for nearly one-third of the total traffic fatalities in the state during that period. In 2017, June, July and August accounted for the three months with the highest fatalities compared to other months that year.

"We can't ignore the data - more fatalities happen on Colorado roads between Memorial Day and Labor Day than any other stretch during the year," said Darrell Lingk, director of the Office of Transportation Safety at CDOT. "That's why we're ramping up our efforts during this 100-day period to ensure everyone travels safely."

"With more cars on the roads there is a higher risk for crashes to happen in the summer," said Col. Matthew Packard, chief of the CSP. "We hope our increased efforts during this 100-day span can keep people safe and even save lives."

CDOT will be launching several high-visibility safety campaigns and heightened enforcement periods in an effort to keep Coloradans safe this summer:

### **Impaired Driving**

Last June, 19 people were killed in alcohol-related crashes on Colorado roads.

CSP and local law enforcement agencies are teaming up for the "Summer Blitz" DUI enforcement. CDOT and 101 participating law enforcement agencies hope to save lives by removing impaired drivers from Colorado roads during the heightened enforcement. A total of 508 DUI arrests were made during the enforcement period last year.

CDOT is also getting ready to launch a summer-long effort to promote the use of smartphone breathalyzers to curb impaired driving. In conjunction with BACtack, a manufacturer of personal smartphone breathalyzers, CDOT's goal is to raise awareness among Coloradans of the mobile breathalyzers as a tool to make informed, safe decisions and prevent impaired driving. CDOT representatives will be at various events throughout the summer to reach drinkers and showcase the breathalyzers in person.

### **Seat Belt Safety**

Wearing a seat belt is the best defense to protect you from an impaired or distracted in a crash. To encourage more drivers to buckle up, CDOT, CSP and local law enforcement agencies recently teamed up for a statewide "May Mobilization" Click It or Ticket high-visibility seat belt enforcement from May 21 to June 3. A total of 5,877 drivers and passengers were cited during the enforcement for not buckling up, including 239 drivers who had an

Staff report From June 15-25, CDOT, improperly restrained child check events in communities under the age of 15 in their vehicle. The Loveland Police Department (464 citations), Arapahoe County Sheriff's Office (355 citations) and Longmont Police Department (315 citations) recorded the highest number of tickets statewide. > Click It or Ticket will return for a July enforcement period targeting rural areas of Colorado beginning July 16 through July 22. Last year, 1,221 unrestrained drivers and passengers were cited throughout the state during the enforcement.

> In conjunction with the Click It or Ticket summer enforcement periods, CDOT is airing new safety ads featuring real Coloradans to promote seat belt use. CDOT interviewed people throughout the state to learn their reasons for buckling up in the hopes that these messages will inspire fellow Coloradans to do the same.

**Child Passenger Safety** Only one in four children are properly secured in their car seat, and car crashes are a leading cause of death in children ages 1-12, according to the National Highway Traffic Safety Administration (NHTSA). To increase car seat safety education and resources for parents, Car Seats Colorado – a joint initiative between CDOT and CSP – will host car seat

across Colorado. In addition, parents and caregivers can have their car seat checked by a certified Child Passenger Safety technician at any time by visiting a Car Seats Colorado inspection station. For more information, resources on proper car seat fit and a list of inspection station locations statewide, visit CarSeatsColorado.com.


### **Motorcycle Safety**

Motorcycle deaths have spiked 44 percent in Colorado in recent years. Motorcycle crashes often happen when a driver turns left in front of an oncoming motorcycle. This summer, CDOT's motorcycle campaign will raise awareness of the importance of checking blind spots and "looking twice" for motorcyclists when pulling onto roadways.

### **Teen Driver Outreach**

According to data from AAA, 10 people will die in a crash involving a teen driver each day during the 100 days between Memorial Day and Labor Day. CDOT will continue public outreach about Colorado's Graduated Driver Licensing (GDL) laws designed to help teen drivers develop safe driving skills while following designated restrictions in their first years of driving.






