

**Schedule of criminal penalties for criminal-offense violations of the
Southern Ute Indian Tribe Traffic Code**

Adopted by the Southern Ute Indian Tribal Council by Res. No. 2018-131, on July 31, 2018.

Driving under the influence (14-4-101(1))	Class 1 Up to 1 year jail Up to \$5,000 fine Two years of probation
Driving while ability impaired (14-4-101(2))	Class 1 Up to 1 year jail Up to \$5,000 fine Two years of probation
Aggravated DUI (14-4-101(3))	Class 1 Up to 1 year jail Up to \$5,000 fine Two years of probation
Vehicular assault (14-6-101)	Class 1 Up to 1 year jail Up to \$5,000 fine
Vehicular homicide (14-6-102)	Class 1 Up to 1 year jail Up to \$5,000 fine
Careless driving resulting in death or serious bodily injury (14-6-105)	Class 1 Up to 1 year jail Up to \$5,000 fine
Reckless driving (14-6-103)	Class 2 Up to 270 days in jail Up to \$2,500 fine
Eluding	Class 2

Violating restricted licenses for alcohol offenses (14-7-103)	Class 2 Up to 270 days in jail Up to \$2,500 fine
Driving under cancellation, suspension, revocation, or denial (14-7-106(1))	Class 2 Up to 270 days in jail Up to \$2,500 fine
Speed contests (14-14-103(1) or (2))	Class 2 Up to 270 days in jail Up to \$2,500 fine
Failure to remain at accident scene involving death or injury (14-18-103)	Class 2 Up to 270 days in jail Up to \$2,500 fine
Failure to report accident resulting in property damage, injury, or death (14-18-104)	Class 2 Up to 270 days in jail Up to \$2,500 fine
Careless, reckless, or negligent snowmobile operation (14-8-103(4))	Class 2 Careless or reckless resulting in death
Careless, reckless, or negligent off-highway vehicle operation (14-8-104(4))	Class 2 – Reckless Class 2 – Careless or reckless resulting in death
Careless driving (14-6-104)	Class 3 Up to 180 days in jail Up to \$1,000 fine

Failure to stop for school bus (14-6-107)	Class 3 Up to 180 days in jail Up to \$1,000 fine
Impeding fire response vehicles (14-6-108)	Class 3 Up to 180 days in jail Up to \$1,000 fine
Throwing or dropping objects at moving motor vehicles (14-6-109)	Class 3 Up to 180 days in jail Up to \$1,000 fine
Operating a motor vehicle in violation of license restrictions (14-7-102)	Class 3 Up to 180 days in jail Up to \$1,000 fine
Failure to report accidents with unattended motor vehicle or property (14-18-105(1))	Class 3 Up to 180 days jail Up to \$1,000 fine
Careless, reckless, or negligent snowmobile operation (14-8-103(4))	Class 3 Reckless
Careless, reckless, or negligent off-highway vehicle operation (14-8-104(4))	Class 3 Careless
Speeding 25 mph over speed limit (14-14-101(1)(b))	Class 3 Up to 180 days jail Up to \$1,000 fine

Driving without a license or permit (14-7-101(1))	Up to 90 days in jail Up to \$500 fine
Careless, reckless, or negligent snowmobile operation (14-8-103(4))	Class 4 Careless
Driving with a fictitious, fraudulently obtained or fraudulently altered license (14-7-107)	Class 4 Up to 90 days in jail Up to \$500 fine
Failure to maintain insurance (14-19-101(1) or (2))	Class 4 Up to 90 days jail Up to \$500 fine
Unlawful use of license (14-7-104)	Class 5 Up to 30 days in jail Up to \$200 fine

Schedule of Criminal Penalties

Class	Maximum Sentence
Class 1	Up to 365 days jail, up to \$5,000 fine, or both
Class 2	Up to 270 days jail, up to \$2,500 fine, or both
Class 3	Up to 180 days jail, up to \$1,000 fine, or both

Class	Maximum Sentence
Class 4	Up to 90 days jail, up to \$500 fine, or both
Class 5	Up to 30 days in jail, up to \$200 fine, or both
